over \$330,000 in direct response to fund critical covid needs.

It has been a long journey, but donor generosity has helped fund the purchase of personal protection equipment, masks, thermometers, visitation tents, vital sign equipment, employee financial assistance and even refrigeration units to help administer vaccines.

We have many things for which to be thankful. The progresses made during these pandemic times would not have been possible without the continued support of so many. Your gifts help impact our ministries of care in such meaningful and inspiring ways. So thank you for your prayers and support, for it is our enduring hope that we continue to walk together during these difficult times to truly make a difference for those in need.

Let me introduce you to Ms. Mary, a dear friend of mine who lived until the end of her life at RoseCrest a Lutheran Homes community of care in Inman. We first met

when she was an independent resident and we became fast friends...sharing stories, learning of adventures and talking about family and shared faith. I visited Ms. Mary often as she moved through our continuum of care. I often found her in the midst of community playing bingo, at worship, painting or making other crafts, or sharing a meal with her friends. She would always call me by name and invite me into her community and we would laugh and visit.

On our latter visits Ms. Mary would say to me "you look familiar, I know you ...I'm sorry my mind is not what it used to be" yet we would visit and laugh like old friends. You see although Ms. Mary was losing some of her memories she knew of our friendship, trust and care. She also knew of her safety in community and would introduce me to staff that had become not only her friends but also an

extension of her family.

I recall with great fondness one of my last visits with her. I found Mary in the sunroom at a table with a large puzzle spread out. She greeted me warmly with "I know you, you look familiar... would you join me?" We sat together in silence with the blessing of trust found in

relationship and put a few pieces together. She later invited me to her room and told me of her latest adventure with family over thanksgiving where they had celebrated at the old

homestead. She was so joyful and generous in sharing these cherished memories with me. We talked of life, we talked of faith, we talked of her peace, laughing and visiting.

Ms. Mary knew she was well taken care of and was at peace with the circumstance of her long life. One way that Mary had taken care of herself was by establishing a life annuity thru the

ELCA Foundation making the Lutheran Homes of SC Foundation the beneficiary. This means that she had an ongoing monthly income until her death at which time the remainder would go to the LHSC Foundation to help with subsidized care.

Mary gave of herself helping others throughout her lifetime and continued

that help to others with this established gift after her death. She would tell me how happy she was to have made the decision to establish this annuity and how beneficial it had also been for her

by bringing her joy knowing that others would be helped at her death.

Planned giving is important not only to the foundation but also for donors. A planned gift can be made in a variety of ways dependent on life needs, tax impacts and donor wishes. Will you join Ms. Mary by finding the joy in knowing others will be well taken care of through your planned gift?

reviewing nearly 1.5 million nonprofits.





In the fiscal year that ended on September 30, 2020, there were 1,674 donors that contributed to the Lutheran Homes of South Carolina Foundation. Their gifts along with income on endowments made it possible for the Foundation to provide \$1,840,977 in support to the ministries of Lutheran Homes.

The generous gifts from our donors certainly gave peace of mind to the 39 residents, hospice patients and clients that had their care subsidized with support totaling \$585,128. They were able to receive the services they needed even though they could not afford to pay the full cost of their care.

Those gifts also made a difference in the quality of life for all of those

served by Lutheran Homes as we spent \$907,742 to fund capital purchases on emergency covid protection equipment, facility upgrades and medical services equipment. Also included was providing an additional \$348,107 to support our ministry sites with program enhancements, operational grants and transfers such as life enrichment, pastoral care and special projects.

Being able to give back is a good thing for the donor as well as the charity. And when you give a gift to the Lutheran Homes of South Carolina Foundation, it is good for our residents, hospice patients, and clients because your gifts will be used to make a real difference in the lives of those we serve.

"Planned giving" is not a term one hears everyday—in fact, most people do not make "unplanned gifts" to charitable interests or to family and friends. All gifts, in effect, are planned gifts. This term, however, is frequently used by many notfor-profit organizations to denote specific gift plans, which carry with them special benefits to the donor and to charity.

There are a variety of ways you can make a planned gift to the Lutheran Homes of South Carolina Foundation and create a legacy. Several suggestions on how your charitable goals can be realized by making a planned gift are listed below.

### A Charitable Bequest in Your Will

A bequest is an ideal way to ensure that the charitable causes which are important to you and your family continue to be supported beyond your lifetime. You can designate a set amount or percentage of your estate, or leave your house or other asset. Bequests to the Foundation can create significant tax savings for your heirs.

### **IRA or Retirement Plan Assets**

You may designate the Foundation as a beneficiary of your IRA or other retirement plan. Since these plans are

taxable to you during life, they are also taxable to your heirs at death. Including estate taxes, sometimes IRA's are taxed up to as much as 50%-75% of their value. This is an ideal asset to leave to charity as it will retain its full value and can be rolled over to charity with no tax consequences.

### **Life Insurance**

You can transfer ownership of a cash value policy during your lifetime and be eligible for an immediate tax deduction based on the policy's current value.

Naming the Foundation as a beneficiary of a life insurance policy can also be a valuable estate planning strategy.
