In our ministries of care at Lutheran Homes of SC we are blessed to serve over fifteen hundred people from all walks of life. While most notably recognized for our older adult care services, a request for help came to the Foundation's attention for a young man in his twenties. He had recently become debilitated with a terminal diagnosis, after already suffering complications from another rare disease.

His younger brother and aging parents have been tasked with the difficult responsibility of trying to work full-time and care for him in their home 24/7. Through the involvement of Lutheran Hospice and BeWell Home Services, the Foundation is able to grant assistance to the family to allow this young man to continue to spend the last

moments of his life at home and receive desperately needed care. The family's burden can now be eased to allow for respite and some sense normalcy for emotional healing through this challenging situation.

Each day I see firsthand the difference that you as donors make in the lives of our residents, clients and hospice patients. Because of your gifts, care can be provided to meet the needs of those who have the additional burdens of worrying about this month's light bill, next week's medical expenses or even where they will live during their last days.

The Foundation is committed to being a faithful steward of your gifts in support of the mission of Lutheran Homes to provide compassionate care and promote the well-being of older adults. During the past year, 43 people have been granted assistance like the



young man here to be cared for with services that likely would not be received elsewhere.

Special Tax-Free IRA Gifts

For those 70½ or older. it is possible to make taxfavored charitable gifts from Traditional and Roth IRA accounts. Your required minimum distribution is commonly used, but a total of up to \$100,000 can be transferred directly from the IRA to one or more qualified charities such as the LHSC Foundation free from federal income tax each year. There may also be state income tax savings. To make such

gifts, it is important to have the amount distributed directly from an IRA to the



qualified charity. Check with us, your IRA administrator or your tax advisor for more information.

Foundation Annual Report

In the fiscal year that ended on September 30, 2018, 1,692 donors contributed \$1,172,908 to the Lutheran Homes of South Carolina Foundation. These gifts along with income on endowments made it possible for the Foundation to provide \$1,697,936 of support for the ministries of Lutheran Homes. This support included spending \$685,558 to subsidize the care of 43 residents, Lutheran Hospice patients and BeWell Home Services clients, funding \$803,340 of capital purchases and providing \$209,038 for program enhancements.

The threat of Hurricane Florence made it necessary to evacuate residents of Franke at Seaside to the Heritage at Lowman on September 11. In addition to buses from the other Lutheran Homes retirement communities, several South Carolina Synod congregations assisted with the evacuation. Mount Hermon in West Columbia, Trinity in Greenville, Ebenezer in Columbia and Pisgah in Lexington offered their buses to transport residents and staff. Fortunately only one bus was needed and Mount Hermon made both the initial and return trips. We are very grateful that these congregations and their drivers offered their assistance to help make sure our residents were safe.

What is a Bequest?

An informal survey revealed that nine out of ten Americans do not know what a bequest is and yet, in the realm of non-profits it is a very common terminology. A bequest is a means to make a gift by naming a recipient of that gift as a beneficiary in your will. Bequests to non-profit organizations like Lutheran Homes are tax-deductible and help reduce estate taxes in large estates.

While some may be unable to define the word bequest, many people still leave funds to charities after death through bequests in their wills than by any other means. That statistic is also true for the ministries of Lutheran Homes. Through the years, our ministries have been named as beneficiaries in the wills of many donors who wanted to preserve their resources during their lifetime but leave a legacy of support for the ministry they cared about after their death.

Through a simple statement in your will you can make a gift of cash, securities or other property, designate a specific dollar amount or fixed percentage of your estate to be bestowed, or leave a portion of your residuary estate after you have

provided for other beneficiaries.

If you would like to help build the longterm strength of one of our ministries but feel you cannot make a significant gift today, your solution may be to make a charitable bequest for that ministry in your will. You may stipulate that your bequest be used for a specific purpose or give the organization the flexibility to use the funds where they are most needed.

If you are considering a bequest with



specific restrictions, you or your legal advisor should discuss plans with our staff to ensure that we are able to fulfill your intentions. We are always available to assist.
