Mission Support in our Ministries of Care



The Foundation carries out its mission of supporting the ministry of Lutheran Homes by providing funds for Subsidized Care, Capital Improvements

and Program Enhancements. While many of you know how we make a difference through subsidizing care for residents and funding capital improvements, some may not be aware of how we enhance programs.

I thought you might be interested in learning more about just a few of the Foundation funds that enhance the program of services administered by our eight ministry of care providers.

Gifts of Grace – This program funds the last wishes of patients served by Lutheran Hospice. Some of the Gifts of Grace we have recently funded include: a trip by ambulance for a patient to see his former home one last time, a ramp at a patient's home so she could enjoy being out in her yard, an anniversary celebration meal for a patient and his wife, and transportation for a patient to attend homecoming at her church for a final time.

Employee Educational Assistance

Fund – This fund helps employees pursue an education program aimed towards a degree or certification. This gives employees an opportunity to apply for reimbursement of the cost of tuition, fees and books. They can pursue a degree that supports their employment at Lutheran Homes or seek certification in an area that benefits their employment.

Chapel Funds – Gifts to these funds, which have been established at several of our communities, are used to enhance worship and pastoral care provided to residents and staff.

Employee Assistance Fund – Funded in large part by contributions from our employees, this fund provides assistance to employees who have experienced a catastrophic event in their lives, such as a fire or tragic illness.

Life Enrichment Funds – These funds have been established at all five of our communities and are used for special projects and activities that enhance the quality of life of our residents.

The mission of Lutheran Homes of South Carolina Foundation, Inc. is to support the ministry of Lutheran Homes of South Carolina by enabling donors, who care about older adults and hospice patients, to achieve their philanthropic goals and by being a faithful steward of their gifts.

Gifts That Keep Giving



By leaving money to charity, donors get to choose how their interests are met by supporting causes they care about even after they are gone.

Using a little foresight, financial gifts to a nonprofit can make a difference to a noble cause, create valuable tax benefits to donors and heirs, and even create an income stream during retirement.

There are a number of vehicles available that can help you take full advantage of charitable tax saving opportunities. Determining which is right

for you depends on the value of your donation and the extent of your estateplanning objectives. One of the simplest gifting strategies is to leave a portion of your assets to a specified

charity in your will. The donor gets the estate tax deduction and the charity gets the contribution once the estate is settled after probate.

An often overlooked consideration is the Individual Retirement Account. Most IRAs have taxable consequences. Heirs even can pay significant income taxes on IRAs, as taxes still must be paid upon withdrawal. But if a charity is listed as a beneficiary, the IRA assets can transfer to the charity tax free. Doing so enables a donor to exclude those assets from the taxable estate, which reduces the amount your family may owe in estate taxes. Most importantly, the charity also receives the full market value of the IRA, instead of after-tax proceeds.

Would you like to make a gift and receive not only a sizeable tax deduction but fixed annual payments, a portion of which will be tax free, during your lifetime



as well? You can, through a charitable gift annuity. A charitable gift annuity, or CGA, enables you to transfer cash or securities to a charitable organization, like the Lutheran Homes of South Carolina Foundation, in exchange for an income tax deduction and fixed annual payments to you (and to a second beneficiary, if you choose) for life. A fixed portion of each annuity payment is tax free, and the calculated annual percentage rate is based on the age of the annuitant.

As stated before, many people like the idea of leaving bequests to favorite charities in their wills. But instead of leaving money to a charity in your will,

> you can put that same money into a Charitable Remainder Trust and collect income while you are still alive.

A Charitable Remainder Trust is an irrevocable trust

that provides you (and possibly other dependents) with income for life. You place assets into the trust, and during your lifetime you receive a set percentage rate from the trust. When you die, the remainder in the trust goes to charity.

Each of the scenarios mentioned above offer opportunities to maximize the value of your charitable contributions and minimize taxes. Donors should consider all strategies available to them in order to determine the best estate planning method to fit their needs, including consulting a personal tax professional. Foundation Financial Report



Through our Fiscal Year End 2021-22, there were 1,791 donors that contributed to the Lutheran Homes of South Carolina Foundation. Their gifts along with income on endowments made it possible for the Foundation to provide \$2,077,164 in support to the ministries of Lutheran Homes.

The generous gifts from our donors certainly gave peace of mind to the 23 residents, hospice patients and clients who had their care subsidized with support totaling \$431,186. They were able to receive the services they needed even though they could not afford to pay the full cost of their care.

Those gifts also made a difference in the quality of life for all of those served by Lutheran Homes as we spent \$980,825 to fund capital purchases, facility upgrades and medical services equipment. Also included was providing an additional \$665,153 to support our ministry sites with program enhancements, operational grants and transfers such as life enrichment, pastoral care and special projects.

Being able to give back is a good thing for the donor as well as the charity. And when you give a gift to the Lutheran Homes of South Carolina Foundation, it is good for our residents, hospice patients, and clients because your gifts will be used to make a real difference in the lives of those we serve.
