Tax-Free IRA Gifts



In 2012, Congress resurrected a popular tax-law provision known as the "IRA charitable rollover" that had expired at the end of 2011. First enacted in the early 2000's, the IRA charitable rollover is a great opportunity for charitable taxpayers to reduce their tax liability.

Also known as a Qualified Charitable Distribution (QCD), this rollover allows IRA owners age 70 1/2 or older to direct up to \$100,000 directly from their IRA to a charity and have it count towards their required minimum distribution (RMD). This offers older Americans the opportunity to give to the causes they care about in their communities without suffering adverse tax consequences. The regulation allows many older investors to transfer funds from an individual retirement account directly to a qualified charity so that the full amount of the distribution is transferred with zero taxable income for the individual or charity.

Individuals who own an IRA and wish to make a gift know that there is more to charitable giving than just the financial and tax advantages. Donors who make a gift know the personal satisfaction that comes from supporting our ministries and that they are making a difference for those in need of special care and assistance. You can contact your financial advisor to easily make a distribution to support the charitable interests most important to you.

Foundation Financial Report



This past Fiscal Year 2022-23, there were 1,675 donors that contributed to the Lutheran Homes of South Carolina Foundation. These gifts along with income on endowments made it possible for the Foundation to provide \$2,010,623 in support to the ministries of Lutheran Homes.

This generosity from our donors helped give peace of mind to the 20 residents, hospice patients and clients that had their care subsidized with grants totaling \$501,317. They were able to receive the services needed even though they could not afford to pay the full cost of their care.

Gifts also made a difference in the quality of life for those served by Lutheran Homes as we spent \$1,219,368 to fund capital purchases, facility upgrades and essential equipment. Additionally, \$289,938 was distributed to supply our ministry sites with program enhancements, operational grants and support for life enrichment, pastoral care and special projects.

Being able to give back is a good thing for the donor. And when you give a gift to the Lutheran Homes of South Carolina Foundation, it is good for our residents, hospice patients and clients because your gifts are used to make a real difference in the lives of those we serve.
